5. Cancellation Policy & Release Periods

If a confirmed booking is amended or canceled by the booking agent for any reason, the deposit will be forfeited and further penalties are payable by the Booking Agent by the following schedule:

- 60-30 Days Before the scheduled date of arrival: 50 % cancellation fee of the per-person rate
- 29 -15 Days Before the scheduled date of arrival: 75% cancellation fee of the per-person rate
